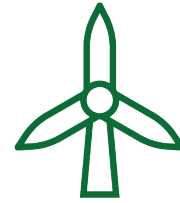

IsDB Group Approvals at a Glance

1975 – 2020 (Q4)

- Total approvals from inception in 1975 to end of fourth quarter 2020 amounted to US\$ 151.6 billion.
- Net Approvals increased significantly from US\$ 4.4 billion in the first decade (1975-1984) to US\$ 83.9 billion in the last decade (2011-2020).
- A total of 1,083 projects in 78 non-member countries across five continents also benefited from the IsDB Group financing.
- The IsDB Ordinary Capital Resources (IsDB-OCR) accounted for 38.7% of the cumulative group net approvals, followed by ITFC (35.7%) and ICD (3.7%). The remaining 21.9% are coming from ICD managed funds (0.7%), Special Assistance Operations (0.5%), Science, technology and innovation (0.004%) and closed funds (20.7%).
- Approvals for the regions are as follows:
 - Middle East and Europe: US\$ 84.7 billion (55.8%).
 - Asia: US\$ 36.6 billion (24.2%).
 - Africa and Latin America: US\$ 24.4 billion (16.1%).
- The total financing for the top ten countries represent about 62.2 percent of total IsDB Group net approvals as follows:
 - Bangladesh: US\$ 22.3 billion (14.7%).
 - Pakistan: US\$ 13.3 billion (8.8%).
 - Egypt: US\$ 13.2 billion (8.7%).
 - Turkey: US\$ 12.3 billion (8.1%).
 - Morocco: US\$ 6.9 billion (4.6%).
 - Iran: US\$ 6.3 billion (4.1%).
 - Indonesia: US\$ 5.8 billion (3.8%).
 - Saudi Arabia: US\$ 5.5 billion (3.6%).
 - Tunisia: US\$ 5.0 billion (3.3%).
 - Senegal: US\$ 3.8 billion (2.5%).
